1. Description:

- 11'1" x 15'2" x 9'3" Walk – in Freezer Room Insulation: 4" High Density Urethane Foam in Place Finish .26ga White Galvalume for Walls, Ceiling One 36" x 78" Heavy Duty Swing Door with Heaters Diamond Plate Floor for Freezer, Miscellaneous Kit for installation include: Aluminium Angels, Flashing, Screws and Channels.
- Keeprite Refrigeration 3.5 H. P Condensing Unit with Copeland Scroll Compressor for Low Temperature Including: Electrical Box, Outdoor Housing, Liquid Line Filter and Sight Glass, Receiver, Service Valves, High- and Low-Pressure Controls, Suction Accumulator and ED Kit Voltage: 208-230V/3ph/60Hz for Refrigerant R404A.

- Payment terms and conditions.

c) Supporting Documents:

- References from previous clients for similar projects
- Any additional documents or information to support the bid.
